## MASTER AND Ph.D. PROGRAMS

### Study programs

The Faculty is accredited as the Institution for three study programs at the master academic studies and one at the doctoral studies:

- Study program master academic studies (postgraduate of one year) **Information Management** (60 ECTS)
- Study program (postgraduate of one year) **Industrial Economic Management** (60 ECTS)
- Study program (postgraduate of one year) **Business Law** (60 ECTS)
- Study program (doctoral studies – three years) **Business management** (180 ECTS)

### Note:

The Faculty is in process of accreditation for a new Ph.D. study program, doctoral studies – three years, **Law**.

### Who can enroll in Master and Doctoral studies at the Faculty of Business and Law?

Applicants eligible to enroll in the postgraduate Master academic studies should have successfully completed undergraduate studies at a higher education institution whose programs belong to the scientific fields of economics, business, management, technical, technological or mathematical sciences.

To enroll in the first year of the doctoral studies can apply all those who have completed postgraduate - master studies in the field of Socio-Humanities.

### Admission to the first year of study

According to the procedure prescribed by the Ministry of Education, Science and Technological Development of the Republic of Serbia, the admission is without taking the classification exam, and after passing validation of previous diplomas.
